What is this product?

TYPE OF PRODUCT

The product is a sub-fund of Universe, The CMI Global Network Fund, an Undertaking for Collective Investment in Transferable Securities (UCITS) incorporated as a variable capital investment company (SICAV) under the laws of Luxembourg.

TERM

The Sub-Fund is established for an unlimited duration. However the Board of Directors may decide to close this product under certain circumstances.

OBJECTIVES

The Sub-fund aims to offer a combination of income and long-term total return.

The Sub-fund normally invests principally in a diversified portfolio of investment grade rated bonds issued by governments and public corporations that are located in the member countries of the Organisation for Economic Cooperation and Development (OECD).

The Sub-Fund is actively managed without any reference to a benchmark. The Investment Manager has discretion over the composition of its portfolio subject to this objective and investment policy.

In choosing investments, the investment manager uses one team to research and recommend possible securities and a second team to choose investments and assemble a properly balanced portfolio.

The Sub-fund may use Derivatives for efficient portfolio management, to manage risks or to seek investment gains.

The Sub-fund may hold ancillary liquid assets.

The Sub-funds does not promote environmental or social characteristics, or has as objective sustainable investment. Please refer to the Prospectus for more information about the Sustainable Finance Disclosure Regulation ("SFDR") classification of the Fund.

These shares are accumulation shares. Income and capital gains are included in the NAV calculation.

INTENDED RETAIL INVESTORS

The product is suitable for retail investors with limited knowledge of the underlying financial instruments and no financial industry experience. The product is compatible with investors who may bear capital losses and who do not need capital guarantee. The product is compatible with clients looking for growing their capital and who wish to hold their investment over 5 years.

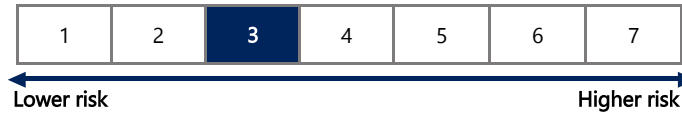

What are the risks and what could I get in return?

Risk indicator



The risk indicator assumes you keep the product for 5 years.

What happens if Lemanik Asset Management S.A. is unable to pay out?

What are the costs?

Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does.

The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

- In the first year you would get back the amount that you invested (0% annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario.

(*) This illustrates how costs reduce your return each year over the holding period. For example it shows that if you exit at the recommended holding period your average return per year is projected to be 7.8% before costs and 7.2% after costs.

We have classified this product as 3 out of 7, which is a medium-low risk class.

This rates the potential losses from future performance at a medium-low level, and poor market conditions are unlikely to impact our capacity to pay you.

How long should I hold it and can I take my money out early?

Recommended holding period (RHP): 5 years.

The RHP was chosen to provide a consistent return less dependent on market fluctuations.

Redemptions are possible every Dealing Day (a Business Day, i.e. any full day on which banks are open for business both in Luxembourg and London). All redemption requests must be received in good order by the Registrar and Transfer Agent prior to 1 p.m (Central European time) on the relevant Dealing Day. Redemption proceeds shall be paid in the relevant reference currency usually within one (1) Business Days following the relevant Dealing Day.

How can I complain?
