What is this product?

TYPE OF PRODUCT

The product is a sub-fund of Universe, The CMI Global Network Fund, an Undertaking for Collective Investment in Transferable Securities (UCITS) incorporated as a variable capital investment company (SICAV) under the laws of Luxembourg.

TERM

The Sub-Fund is established for an unlimited duration. However the Board of Directors may decide to close this product under certain circumstances.

OBJECTIVES

The Sub-fund aims to mirror, as closely as possible, the performance of the Index. The anticipated tracking error is not expected to exceed 0.20%.

The Sub-fund is passively managed and intends to replicate the FTSE All-Share Custom Screened Index by holding the equity securities, which make up the relevant benchmark index, in similar proportions to the benchmark.

The Sub-fund normally invests mainly in a diversified portfolio of shares of companies that are included in the FTSE All-Share Index.

The Sub-fund may use Derivatives and currency forward contracts for efficient portfolio management, to manage risks or to seek investment gains.

The Sub-fund may hold ancillary liquid assets.

You may redeem shares of the Sub-fund on any business day in Luxembourg.

The Sub-funds does not promote environmental or social characteristics, or has as objective sustainable investment. Please refer to the Prospectus for more information about the Sustainable Finance Disclosure Regulation ("SFDR") classification of the Fund.

These shares are accumulation shares. Income and capital gains are included in the NAV calculation.

INTENDED RETAIL INVESTORS

The product is suitable for retail investors with limited knowledge of the underlying financial instruments and no financial industry experience. The product is compatible with investors who may bear capital losses and who do not need capital guarantee. The product is compatible with clients looking for growing their capital and who wish to hold their investment over 5 years.

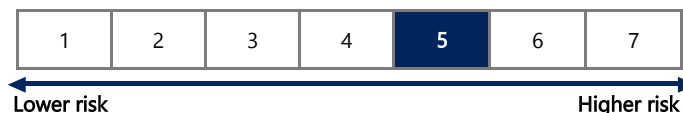

What are the risks and what could I get in return?

Risk indicator



The risk indicator assumes you keep the product for 5 years.

What happens if Lemanik Asset Management S.A. is unable to pay out?

Lemanik Asset Management S.A. is not making any payment to you in relation to this Fund and you would still be paid in case of a default from Lemanik Asset Management S.A.

The Fund's assets are held with CACEIS Investor Services Bank S.A. and are segregated from the assets of other sub-funds of the Company. The assets of the Fund cannot be used to pay the debts of other sub-funds of the Company.

What are the costs?

The person advising on or selling you this product may charge you other costs. If so, this person will provide you with information about these costs and how they affect your investment.

Costs over time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does.

The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

- In the first year you would get back the amount that you invested (0% annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario.

(*) This illustrates how costs reduce your return each year over the holding period. For example it shows that if you exit at the recommended holding period your average return per year is projected to be 10.3% before costs and 10.1% after costs.

We have classified this product as 5 out of 7, which is a medium-high risk class.

This rates the potential losses from future performance at a medium-high level, and poor market conditions will likely impact our capacity to pay you.

How long should I hold it and can I take my money out early?

Recommended holding period (RHP): 5 years.

The RHP was chosen to provide a consistent return less dependent on market fluctuations.

Redemptions are possible every Dealing Day (a Business Day, i.e. any full day on which banks are open for business both in Luxembourg and London). All redemption requests must be received in good order by the Registrar and Transfer Agent prior to 1 p.m (Central European time) on the relevant Dealing Day. Redemption proceeds shall be paid in the relevant reference currency usually within one (1) Business Days following the relevant Dealing Day.

How can I complain?
